SUMMARY

- Purpose.** Obtain SECAF signature at Tab 1 establishing policy and standard for CoT 1.0.
- Background.** CoT should be formally adopted as an Air Force standard for the transmission of what/when/where information to the tactical edge. CoT was developed by MITRE for use by the DoD. SAF/XC intends to publish the CoT 1.0 standard under the SECAF's authority and manage it under the Transparency IPT (TIPT) through the Community of Interest (COI) Coordination Panel. ESC proposes standing up a CoT Project Office to provide technical expertise and manage the CoT baseline in support of the COI Coordination Panel. The attached memo lays out a gameplan for bringing forward the policy and standard as tasked by the TIPT Chair.
- Views of others.** See attached comment matrix for resolution of all comments during coordination.
- Recommendation.** SECAF sign the memo at Tab 1.

SUBJECT: USAF Cursor on Target (CoT) Standard for Net-Centric Interoperability


Recognizing that information sharing is key to creating a net-centric Department of Defense, I am directing using Cursor-on-Target (CoT) as an Air Force data exchange standard for what/when/where information to Air Force tactical edge platforms/systems. The CoT core structure is operational, or has demonstrated capability to achieve rapid, machine-to-machine interoperability in more than 130 DoD and Civil systems. The XML data model it uses is open and simple, enabling flexible integration of AF and DoD tactical systems.

The strength of CoT is its simplicity in transmitting/publishing only that set of unambiguous what/when/where information that is required at the tactical edge. CoT compatibility with the evolving DoD run-time environment will ensure that published information gets to the tactical edge where bandwidth in support of our warfighters is very limited. This will augment the data services efforts within our service-oriented environment. The concept for use of CoT will be incorporated into the Air Force metadata environment concept.

Directing CoT as a standard supports DoD Directive 8320.2, "Data Sharing in a Net-Centric Department of Defense" which directs DoD Component Heads to ensure implementation of Net-Centric data sharing. Tactical edge platforms/systems using the CoT standard will be transitioned to the DoD universal core standard in turn. To accomplish this action, I am directing the tasks outlined below.

SAF/XC will draft, within 90 days, Air Force policy direction to adopt CoT, to include vetting appropriate timelines and waiver procedures for incorporation. The chartered Community of Interest (COI) Coordination Panel in coordination with AFMC will publish the authoritative Air Force CoT 1.0 baseline schema within 90 days and will manage that baseline under my authority as executed through the Transparency IPT (TIPT), ensuring it is compatible with net-centric data standards across the DoD and Intelligence Community. The CoT 1.0 baseline schema will be replaced by the universal core standard upon adoption of the universal core standard by the DoD and Director of National Intelligence Chief Information Officers. The TIPT sub-IPT leads and their COIs will incorporate the CoT standard into their vocabulary efforts that transmit data to the tactical edge. PEOs will coordinate and institute the implementation of CoT within systems they acquire or develop as funded by lead commands.
